Permit to Keep a Restricted Dog

State law requires that the owners of *American Pit Bull or Pit Bull Terrier, Dogo Argentino, Presa Canario Japanese Tosa* and *Fila Brasileiro* (including cross breeds) have a permit from Council to keep a restricted dog

Dangerous Dogs

In the event that your dog is declared dangerous an additional fee of \$170.00 will be payable at the time of the declaration and thereafter on an annual basis.

PLEASE NOTE: DOG REGISTRATION FEES ARE NOT SUBJECT TO GST

Registration of your dog	- every dog from the age of four (4) months kept in a settled area as defined in Local Law No. 1 (Administration) is to be registered with this Council. Settled areas include City of Warwick and Rosenthal Heights and the townships of Allora, Dalveen, Emu Vale, Karara, Killarney, Leyburn, Maryvale, Mt Colliery, Pratten, Tannymorel and Yangan.

Dog Registration Enquiries	- may be made by phoning: Customer Service 4661 0300
Discount	- only available if registration is paid during discount period.
Guide Dog/Assistance Dog	- keepers of a dog who produce evidence that the dog is registered with the appropriate authorities as seeing-eye dogs/hearing-aid dogs shall be issued registration at no charge.
Dog Obedience/Training Organisation	- keepers of dogs who produce a certificate of Training in Dog Obedience provided by a recognised dog obedience club or recognised training organisation shall be entitled to a 50% reduction in fees.
