## **CONDITIONS**

### **Types of Membership**

1. Aquatic membership – includes unlimited use of the 25m pool, hydrotherapy pool, (during supervised hours) and rapid river.
2. Gym membership includes unlimited use of the Gymnasium only.
3. Unlimited use is subject to Management's rights under clause 13 and 14.
4. Gold membership includes all aquatic and gym membership benefits, together with all dry courts, rock wall and all aquatic and group fitness classes.
5. Applicants for Gold or Gym Membership must be over the age of 16, and those applicants under the age of 18 must have the Membership Agreement signed by a parent or legal guardian.

### **Membership Conditions**

6. Payment for all memberships (excluding squads and aquatic education) is either up front for 3 months or 1 year, or by Direct Debit.
7. There is a 2 business day cooling off period on this application. If you terminate your membership in that time, your payment will be refunded and any Direct Debit will be cancelled.
8. Membership cards are to be presented to Reception on arrival every time you use the Centre.
9. Management's only responsibility to you is to conduct the Centre so it does not have any hazards or conditions injurious to persons of ordinary good health and free from special health conditions or health sensitivities. Management is not responsible for advising on health or injury risks of any activity.
10. You use the facilities at your own risk<sup>1</sup>, subject only to Management's responsibility under clause 9. You indemnify Management in respect of any claim made as a result of your death or injury which involves your special health conditions or health sensitivities. You also indemnify Management against any claims for loss, damage or injury which relates to your entry to the Centre or your use of any facilities, other than loss, damage or injury for which Management is responsible under the clause 9.
11. The Membership lasts for the period set out in the Membership Details or until it is terminated in accordance with these conditions. If you pay by direct debit, your membership continues for two weeks after the last debit from your account or until terminated in accordance with these conditions.
12. Membership is non-transferable, and the Management may refuse admission to a person seeking to use another person's membership.
13. Management may remove the Member from the Centre, or cancel any membership due to unacceptable behaviour. Management can determine in its discretion what counts as unacceptable behaviour and its decision can only be overturned if it was grossly unreasonable.
14. Management reserves the right to refuse entry to the Centre and restrict access to any area of the Centre, whether for repair, maintenance or because of booked functions or other restricted use. Management also retains total control of standards, policies and operations of the Centre at all times.

<sup>1</sup> If you are over 35 years of age and are inactive or you have an injury/illness or medical condition that you are aware of, you are strongly recommended to seek a medical clearance from your doctor before starting any exercise program.

- 15. You have a right to terminate your membership on becoming permanently incapacitated.
- 16. Membership payments are only refundable under conditions approved by Management. However if you produce a doctor's certificate showing you have become permanently incapacitated a pro rata refund will be given to the time of receiving the doctor's certificate and Direct Debits will be cancelled from that time.
- 17. In these conditions "Council" and "Management" both include the Warwick Shire Council and its employees and "Centre" means the Warwick Indoor Recreation and Aquatic Centre.

**Direct Debit Payment Conditions**

- 18. Direct Debits are made fortnightly, and are not affected by you not using the facilities.
- 19. Direct Debits continue until cancelled by at least 30 days notice in writing by you. Cancellation by phone will not be accepted under any circumstances. Two more Direct Debits will be made after a cancellation notice is received.
- 20. If requested by you in writing Management may suspend a membership during a period not exceeding one month in each calendar year. The effect of a suspension is to give you a free additional period of membership equal to the length of the suspension. Where you wish to suspend for health reasons for more than one month a doctor's certificate must be provided.
- 21. Management may change the amount of a Direct Debit by notice to your financial institution. Such a notice may only be given in the event and to the extent of any Council increases in membership fees. If the Financial Institution requires your authority for an increase, your membership will be suspended until such authority is given.
- 22. A non-refundable admission fee of an amount determined by Council is applicable at the commencement of your paying by Direct Debit.
