



PLANNING SCHEME POLICY No. 1

CULTURAL HERITAGE

1.0 Planning Scheme Policy Direction

1.1 The identification of places having cultural heritage significance (other than those associated with Aboriginal culture) was the subject of the *Warwick Shire Council Cultural Heritage Study* which was undertaken in 1996 and 1997. In addition to identifying places of cultural heritage value, this study made recommendations regarding measures to be implemented through the planning scheme to ensure their protection.

1.2 In the planning scheme, overarching policy direction in this regard is provided by *Desired Environmental Outcome 2.4.2*, which states:

"There will be effective conservation of places of cultural heritage significance in the Shire and new development which sensitively responds to them."

1.3 The planning scheme incorporates several measures intended to support this desired environmental outcome. The primary ways in which these measures will collectively operate are described below:

- (i) Places in the Shire of identified cultural heritage significance are listed in the *Register of Cultural Heritage Places* appended to this policy. Development which would involve the demolition or removal or external building work to listed buildings will require impact assessment and applicants will be requested to prepare a *conservation report*. Council will also have regard to the impact of development proposed for nearby sites on the heritage and landscape values of these places.
- (ii) Codes are included in section 4 of the planning scheme for the City Centre, City Frame, City East and Town Centre land use areas shown on the planning scheme maps. These codes are intended to ensure that the design of new buildings and structures will be sympathetic and responsive to the local streetscape character and nearby buildings of heritage value;
- (iii) The planning scheme recognises that places of cultural heritage value will exist that are not identified in this policy. In particular, places associated with Aboriginal culture have not been documented. Where such values are thought to exist on the site of a development requiring impact assessment, Council may request the provision of a conservation report.

2.0 Purpose of This Policy

2.1 Within the above policy context, this planning scheme policy has the following functions:

- the identification of *cultural heritage places* to which the provisions of the planning scheme summarised in part 1.0(ii) apply, through a *Register of Cultural Heritage Places* (refer section 3.0 below);
- the establishment of administrative procedures for the inclusion or removal of places on the *Register of Cultural Heritage Places* (refer section 4.0 below);
- the identification of requirements for the preparation of a *conservation report* where required (refer section 5.0 below).

2.2 Reference to a *cultural heritage place* within this policy or listed in the register may relate to either an individual or a group of buildings or sites.

3.0 Register of Cultural Heritage Places

3.1 Where, on the advice of a suitably qualified person, Council determines that a place is of cultural heritage significance, the Council may include the place on its Register of Cultural Heritage Places.

3.2 The Council's Register of Cultural Heritage Places is included as a schedule to this planning scheme policy.

3.3 The provisions of the planning scheme summarised in 1.0(ii) apply to those places identified on the Register of Cultural Heritage Places.

4.0 Adoption and Amendment of the Register of Heritage Places

4.1 The adoption and amendment of the register shall be in accordance with the relevant provisions regarding planning scheme policies the *Integrated Planning Act*.

4.2 In addition to the requirements for consultation about planning scheme policies under the Act, where an amendment of the Register of Cultural Heritage Places is intended, the Council shall notify the owner of each place proposed to be entered on the register by way of the amendment.

4.3 Also in addition to the consultation requirements under the Act, where the Council receives a submission from the owner of a place proposed to be included on the register objecting to its inclusion, the Council is to notify the submitter of its decision where it intends to proceed with the inclusion of the places on the register.

4.4 Within 30 days of receiving a notification referred to in 4.3 an owner may, upon payment of the prescribed fee, request that the proposed inclusion on the register be referred to an independent heritage assessor for assessment and a recommendation of the place's significance.

4.5 Where the independent heritage assessor's recommendation made under 4.4 recommends that the place is not of such significance to warrant inclusion on the register the Council will not include the place on the register.

5.0 Requirements for the Preparation of Conservation Reports

- 5.1 The purpose of preparing a conservation report is to ensure that the cultural heritage significance of the place is understood and has been considered in any proposed development of the place.
- 5.2 Council intends to request the preparation of a conservation report for an application for development requiring impact assessment on any place entered on the register, except where the place has been and remains permanently entered on the Queensland Heritage Register at the time of application. It is advisable that a prospective applicant seeks the advice of the Council as to the scope of such a report likely to be requested.
- 5.3 The scope of any report will be dependant on the nature of the development proposed and the characteristics of the place and its setting. In order to address aspects of relevant to any particular place, the Council may request that a report includes specific information or addresses points or issues of specific relevance to the cultural heritage significance of a place.
- 5.4 Aspects which a conservation report should generally include are listed below:
 - a) sufficient history of the place to understand its origin, changes over time and relevant associations with significant people or events in local history;
 - b) an assessment of the physical condition of the place and its degree of intactness;
 - c) photographs and/or drawings sufficient to identify the place and any relevant components of the place;
 - d) any further research or investigation recommended in the Warwick Shire Council Cultural Heritage Study;
 - e) any specific conservation actions recommended in the Warwick Shire Cultural Heritage Study;
 - f) any specific information or assessment required by subsection 5.3 of this policy;
 - g) a statement of cultural heritage significance of the place which, if it varies from the statement of significance incorporated in the Warwick Shire Council Cultural Heritage Study, must have sufficient, appropriate supporting information to justify the varied statement;
 - h) identification of significant fabric of the place;
 - i) identification of significant setting features of the place;
 - j) an assessment of what impacts the development proposal will have on the cultural heritage significance of the place; and
 - k) where a material change in use is proposed, identification of a range of compatible uses.
- 5.5 Any conservation report conforming to the principles of the Australia ICOMOS Charter for the Conservation of Places of Cultural Significance (The Burra Charter) and its guidelines, or prepared in accordance with J.S. Kerr's "Guidelines for the Preparation of Conservation Plans for Place of European Cultural Significance" shall be sufficient to comply with the requirements of this policy.
